

## **Consent to the processing of personal data and declaration of familiarity with the terms of the event (GDPR principle)**

The person registered through this application for the Event (hereinafter referred to as the "Affected Person") gives in terms of Act No. 18/2018 Coll. on the protection of personal data as amended, in conjunction with the provisions of the Regulation of the European Parliament and the Council (EU) no. 2016/679 of April 27, 2016, General Data Protection Regulation, your consent to the processing of your personal data for the purpose of the company defined below **SunBell, s.r.o., Vážska 305/41 Trenčín, 911 05, ID: 50248740**, (hereinafter referred to as the "Operator").

When registering a minor, his legal representative gives consent to the processing of personal data of the registered person. When registering in a representative office, e.g. members of the relay, confirms that he has the consent of the affected persons he is applying for in representation to give consent to the processing of their personal data for the purpose defined below.

List of provided personal data: Name, surname, gender, date of birth, club to which (if) the Affected person is member, city, email contact, location data, health care insurance information, likeness of the Affected Person captured in photographs and/or recordings from the Event.

Defined purpose: Logging in and registering participation in the Event, processing the Event start list, processing of the Event result list, processing and evaluation of the measurement of the time achieved at the Event, GPS processing location at the Event, publication of name, surname, year of birth, club affiliation and time achieved as sports performance at the Event on the website [www.vysledkovyservis.sk](http://www.vysledkovyservis.sk), processing of personal data for the purpose ensuring that the participant is informed about the organization of the event before, during and after the Event. Furthermore, the execution of a publishing photos and/or videos from the Event, especially on social networks (Facebook, Instagram, etc.), or in posts on the Organizer's website and/or on third-party websites.

Making, publishing photos on the [zosportu.sk](http://zosportu.sk) website and delivering emails in connection with your participation in events.

The legal basis for the processing of this voluntarily provided data is an irrevocable contract within the meaning of Art. 6 par. 1 letter a) GDPR or § 13 par. 1 letter a) of the Personal Data Protection Act, concluded as a result of the registration of the Data Subject of a person, the object of which is mainly to enable the Affected person to participate in the above-mentioned sports event, and/or the provision of other services that are further defined in the description of the event, while participation in the event a the provision of related services by the Operator would not be possible without the conclusion of the above-mentioned contract. Furthermore, the legitimate interest of the Operator in accordance with § 13 par. 1 letter f) of the Act in conjunction with section Art. 6 par. 1 letter f) Regulations, consisting in the promotion of the Operator's events and in raising public awareness of such events with the aim of increasing the number of future participants.

The consent of the Person affected is part of the application for the Event.

The possibility of online registration for a sports event, online publication of results and photos and/or video recordings from event is not primarily intended for persons under the age of 16. Period of validity of consent: Unlimited in accordance with § 10 of Act 18/2018 for statistical purposes.

There will be no automated decision-making during the processing of the Data Subject's personal data (with the exception of automated decision-making for the results of a sports event) or profiling, while the Operator does not with the intention of providing personal data to a third country, an international organization or third parties, with the exception of intermediary.

Above all, the affected person has the right to request from the Operator access to his personal data, their correction, possibly restriction of processing, the right to object to processing, as well as the right to file a complaint with the Office for Protection of personal data, if the Operator and/or intermediary proceeds in the processing of personal data in violation of s Regulation and/or Law. The affected person has the right to revoke the affected person's consent by sending an email to the address [prihlasovanie@sunbell.sk](mailto:prihlasovanie@sunbell.sk) through a request that must contain data: first and last name, name of the Event and email address which was mentioned in the application. Withdrawal of consent does not affect the legality of processing based on prior consent by his appeal.

By checking consent, the Affected person also confirms that he has familiarized himself with the terms and conditions of the event, understands them and undertakes to comply with them. Assumes all the risks arising from participation in this event, bears full responsibility for any injury or accidents and will not file lawsuits or recover damages against the organizers. Acknowledges and agrees that the organizer is not responsible for any damage caused to the health, property and belongings of the event participants. The participant of the event who caused this damage is responsible for any damage to health, property and belongings. Is aware that he/she is obliged to ensure his/her own safety and not to endanger the safety of other event participants with his/her actions.

He acknowledges that in case of any violation of the conditions of the event, safety and organizational instructions, he will be excluded from the competition without reimbursement of the entry fee and other expenses.
